Commitment to achieving Net Zero

One Call 24 Limited is committed to achieving Net Zero emissions by 2050.

Baseline Emissions Footprint

Baseline emissions are a record of the greenhouse gases that have been produced in the past and were produced prior to the introduction of any strategies to reduce emissions. Baseline emissions are the reference point against which emissions reduction can be measured.

Baseline Year: 2021

Additional Details relating to the Baseline Emissions calculations.

2021 emissions have been calculated based on our operational data and reported in accordance with the GHG Reporting Protocol corporate standard.

The Scope 1 direct emissions were zero due to no company owned/leased vehicles and or fuel/gas emissions within the reporting period.

The main Scope 2 energy emissions occurred from the electricity consumption from the organisation, with a small amount of additional emissions produced from staff working at home. These emissions were attributed to additional energy usage that would not have otherwise occurred at home.

The main Scope 3 emissions occurred from staff commuting and business travel. Additional emissions occurred from organisation waste, hotel stays, third party inbound and outbound delivery of goods, and organisation water usage.

Each year, One Call 24 Limited offset the total carbon footprint from the period identified within this report to become certified as a Carbon Neutral Business by Carbon Neutral Britain.

Emissions reduction targets

In order to achieve a 50% reduction in emissions by 2030, One Call 24 Limited is required to reduce its emissions by 210.49 tCO2e over the next 7 years.

This will require a reduction of 7.14% (30.05 tCO2e) per year from the 'Baseline' (first year) assessment of the organisation. A further reduction of 2.5% (10.52 tCO2e) each year is then required in order to achieve Net Zero.

Should significant changes to the business size and structure occur in the future – One Call 24 Limited will amend the 'baseline' assessment year, as well as look at intensity values (tCO2e per million turnover, FTE or other metric), to further track and implement reduction strategies.

Carbon Reduction Projects

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2021 baseline:

- Adoption of LED/PIR lighting controls.
- Limited the number of staff within the office
- Reduction in company travel and flights by implementing virtual meeting tools.
- Invested in reputable carbon offset programs to offset emissions that couldn't be reduced immediately.

The carbon emission reduction achieved by these schemes equate to a 5% reduction against the 2021 baseline.

In the future we hope to implement further measures such as:

- Further reduction in travel emissions by enhancing remote working capabilities.
- Achieving ISO14001 certification for our environmental management system.
- Promote the use of public transport, carpooling, or cycling for commuting.
- Enhance office recycling programs to reduce waste and associated emissions.
- Implement a paperless policy where possible, using digital documents and signatures.
- Conduct regular training sessions for employees on energy-saving practices and sustainability.
- Continuing investing in reputable carbon offset programs to offset emissions that cannot be reduced immediately.

Declaration and Sign Off

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.
